


The December 27, 1968-January 2, 1969, issue of the "Berkeley Barb" carried an article on page 11 under the byline of Stewart Albert who is believed to be identical to captioned Stewart Edward Albert.

This article is a description of certain aspects of life in Toronto and elsewhere in Canada, particularly regarding militant protest activity.

In the article Albert states "I arrived here on a vacation to escape the warm sun and friendships of Berkeley." The article does not state when Albert arrived in Toronto. Later in this article Albert states that "I look forward to returning to Berkeley." Again the article does not state when the author intends to leave Canada.

The "Berkeley Barb" is a weekly newspaper published each Friday in Berkeley, California. It is self-described as a member of the so-called "underground press." Examination of this publication discloses that it is devoted almost entirely to matters relating to anti-war, anti-draft, and other types of protest activity along with articles relating to use of drugs, sexual freedom, etcetera. Stewart Albert has been a long time contributor of articles to the "Berkeley Barb."

STEWART EDWARD ALBERT

On January 7, 1969, an unknown male was contacted at 1049 Keith Avenue, Berkeley, California, the last known address of Stewart Albert. This person advised that Albert is not at home and is in "Toronto or some other place back east." This person stated that he expected Albert to return to Berkeley, but he could not fix the date of this expected return.

For the past three years, Stewart Albert has been a prominent figure in youth protest activity in the San Francisco Bay Area. While in this area, he is observed at nearly every large demonstration opposing United States military action in Vietnam, the Selective Service System, university and college authorities, and other civil authority. In connection with this protest activity, he has been arrested at least three times for misdemeanors occurring during demonstration activities.

[REDACTED] on May 14 and 15, 1966, Albert attended a West Coast Progressive Labor Party (PLP) conference, which was held at San Francisco PLP Headquarters, 2929 - 16th Street, San Francisco, California.

A characterization of the Bay Area PLP is contained in the Appendix attached hereto.

[REDACTED] Stewart Albert was reported to have recently quit the PLP.

[REDACTED] Stewart Albert was on the staff of the National Mobilization Committee to End the War in Vietnam (NMC) at its headquarters, 857 Broadway, New York City.

[REDACTED] Albert's position at that time was editor of "The Mobilizer," an official publication of the NMC.

The NMC was originated at a conference in Cleveland, Ohio, in November, 1966, for the specific purpose of holding massive anti-war demonstrations in New York City and in San Francisco on April 15, 1967. The organization was

first titled as the Spring Mobilization Committee to End the War in Vietnam (SMC). Its first Chairman was the noted late pacifist A. J. Muste. The founding convention urged all persons interested in the anti-war movement to converge on either San Francisco or New York City on April 15, 1967, to participate in mass marches and rallies protesting United States intervention in Vietnam. East Coast and West Coast headquarters for the SMC were established in New York and San Francisco. The above demonstrations were held. The SMC, however, remained active. Eventually it evolved into the NMC.

In March, 1968, a leaflet appeared in New York City, which announced the formation of the Youth International Party (YIP). The leaflet stated that a group of 25 artists, writers, and musicians have agreed to participate in the founding of this party. The leaflet stated that YIP will stage a massive youth festival in Chicago during the time of the Democratic National Convention. The leaflet urged people to join YIP in Chicago for a festival of youth, music, and theater. The leaflet did not announce any plans for YIP other than the Chicago activity. One of the persons listed as an original founder of YIP was "Stu Albert."

[REDACTED] Albert was arrested in Chicago on August 23, 1968 and charged with disorderly conduct. This arrest arose out of his participation in demonstrations occurring during the Democratic National Convention held in that city. There has been no disposition of this case as of December 2, 1968.

For the past 3 year period ALBERT has been a leading participant and oft times leader of virtually every demonstration and civil disturbance of significant size which has taken place in the San Francisco Bay Area. Since April 1966, ALBERT has been arrested in Sacramento, California, Berkeley, California, Chicago, Illinois and Washington, D.C. while participating in civil disturbances. He was a founding member of the Youth International Party (YIP) which was instrumental in causing great disturbances in Chicago during the 1968 Democratic National Convention.

ALBERT is a writer whose works are carried by the so-called underground press tabloids of the United States by which method he solicits support for many organizational efforts protesting United States involvement in Vietnam, the Selective Service System, college and university authorities and other civil authorities. ALBERT is a long time friend and associate of Key Activist JERRY CLYDE RUBIN. Many of his activities have been conducted while in the company of RUBIN.

ALBERT has returned to the San Francisco Bay Area after being in New York for approximately 14 months. Subject resided, upon his return to Berkeley, at 1049 Keith Avenue, Berkeley. On 1/20/69 a telephone call was placed to this address in an effort to contact ALBERT for purposes of interview in an Anti-Riot Law matter. An unknown woman answered and stated that ALBERT was no longer living at this address. This woman was vague and evasive about STEWART ALBERT having moved out and she would not say where ALBERT was currently residing.

ALBERT has been observed in Berkeley on many occasions by Special Agents of this office through the present date and is undoubtedly still residing in Berkeley.

ALBERT was interviewed on 12/9/68 by Agents of this office in an Anti-Riot Law matter at which time he advised that his occupation was as a free lance writer and that he was writing primarily for the so-called "underground press syndicate." He normally furnishes his articles to the "Berkeley Barb." It has been observed that one or more articles by ALBERT has been appearing in every recent issue of the Berkeley Barb.

An FD 397 has been submitted recommending ALBERT for inclusion on the Agitator Index.

This office has no indication of contemplated foreign travel by ALBERT. WFO advised by a referenced letter that Subject does not have a current valid U.S. passport. San Francisco will be alert to any indication that ALBERT plans overseas travel and appropriate LHM and passport checks will be submitted.

The coverage of ALBERT's day to day activities is somewhat more difficult than in the case of many other Subjects because ALBERT is not known to be a member of any particular organization. He was at one time a member of the Progressive Labor Party (PLP) but is thought to have quit the Party in the fall of 1966. Since that time he is not known to have had any organizational affiliations other than being listed in literature as one of the original founders of the Youth International Party (YIP), also known as YIPPIES. This office has no indication that YIP is an ongoing organization in the San Francisco area. Because our security informants are oriented toward the coverage of organizational affairs they are not in a position to regularly report on ALBERT's day to day plans.

These informants will be advised that this office is particularly interested in ALBERT's activities and that all pertinent information regarding his whereabouts and activities should be noted and promptly furnished the operating agents.

It is expected that investigative effort will develop the whereabouts of Subject's residence within a short time. When his residence is determined concentrated effort will be made to develop a good [REDACTED] source. Because ALBERT's activities, particularly his travel plans, cannot be expected to be known by organizational informants, it is felt that a [REDACTED] source would be valuable. Consideration may have to be given to paying [REDACTED] source for rendering services beyond that of a usual security [REDACTED] source.

At this moment this office is not aware of any income which ALBERT receives other than the payment he receives from the Berkeley Barb for his articles. [REDACTED]

[REDACTED] the Barb pays a normal rate of \$1 per column inch for published work. At this rate ALBERT cannot be obtaining more than perhaps \$25 a week for his Barb writing. Although ALBERT's living standards have been observed by interviewing agent to be somewhat spartan, it is felt that he is not maintaining himself on as little as \$25 per week. Efforts will be made through usual investigative techniques to determine his other source of income if any. [REDACTED]

ALBERT's writings in full or summarized, as appropriate in each case, will be furnished the Bureau in investigative reports.

Bureau will be kept advised of the progress being made in this case.

I. BACKGROUND

A. Birth

On September 16, 1960, [REDACTED] examined birth records at the Bureau of Vital Statistics for the Borough of Manhattan, New York City. A record was found recording the birth of STEWART EDWARD ALBERT on December 4, 1939, at Lenox Hill Hospital, New York City. The parents are listed as HAROLD ALBERT and ROSE ALBERT, nee SCHWARTZ.

ALBERT, in 1957, furnished information in New York City to the effect that he was an only child.

C. Education

STEWART EDWARD ALBERT, 2148 East 29th Street, Brooklyn, New York, born December 4, 1939, at New York, New York, unmarried, was admitted to Pace College, New York City, on September 24, 1957. He withdrew for personal reasons in the spring term of 1958 but re-entered for the fall term of 1958 and is presently a day student majoring in Marketing, pursuing a Bachelor of Business Administration degree.

He graduated from James Madison High School on June 23, 1957, with an average of 79.2. While in high school, ALBERT was president of the Weight Lifting Club, a member of the Service League, the Honor Guard, and the Late Squad Guard. According to information received from the above high school, ALBERT had an Intelligence Quotient of 106 (Pinter Intelligence Scale).



In regard to the arrest of April 9, 1966, [REDACTED]

[REDACTED] on April 18, 1966, that on April 9, 1966, the subject and an individual named [REDACTED] were distributing anti-Vietnam literature on the grounds of the State Capitol and offered some to [REDACTED], a resident of Sacramento. [REDACTED] told the Subject and [REDACTED] that he had a son in Vietnam and called [REDACTED] and ALBERT "yellow bastards." [REDACTED] then told [REDACTED] that he was stupid to allow his son to enter the military, at which time [REDACTED] struck [REDACTED] in the face with his fist. When ALBERT stepped forward to defend [REDACTED] struck ALBERT in the face with his wrist. The arrest by the State Police followed immediately.

in Berkeley, California.

On the night of April 12, 1966, a number of PLP members had attended a Vietnam Day Committee (VDC) demonstration in front of the Berkeley City Hall which had been broken up. A police officer stopped the group because he claimed he heard someone shout an obscene word, and he arbitrarily arrested one of the group. The rest of the PLP group demanded to know what right the officer had to arrest someone on mere suspicion. The officer whistled for aid, and fellow officers, apparently believing that their fellow officer was being attacked, began to drag the PLP members off, including STEWART ALBERT and [REDACTED] and were arrested.

A characterization of the VDC is contained in the appendix attached hereto.

In connection with the Subject's arrest on November 30, 1966, an article in the December 1, 1966, issue of "The San Francisco Chronicle," daily newspaper, noted that Alameda County Sheriff's Deputies had arrested nine persons on the

UCB campus during a day-long student demonstration. The article noted that the apparently spontaneous demonstration erupted in the Student Union building in protest over a Navy recruiting table being manned there by two Navy officers. The demonstrators protested that not only was the military recruiting allowed but that a student and non-student manning a draft information table had been ousted from the Student Union building. The article noted that six persons whom school officials believed responsible for the trouble were arrested including STEWART ALBERT. Three other students were arrested for interfering with officers in connection with these arrests.

An article in the January 13, 1967, edition of the "Daily Californian" noted that the six non-students who were arrested on November 30, 1966, on the campus at UCB had announced that they are violating an order to to comment on their court case to the press.

The article noted that Berkeley Municipal Court Judge GEORGE BRUNN had imposed a "gag rule" on December 16, 1966, in order that the defendants could receive a fair trial. The six defendants were planning to break the order because they claimed it would deny them a fair trial.

The January 27, 1967, issue of the "Daily Californian" noted that the Subject and three other defendants have been charged with contempt of court for deliberately violating a court order forbidding them to discuss their recent trial.

The "Daily Californian" is a campus newspaper published by the Associated Students of the UCB.

On August 26, 1968, [REDACTED] Office of the Clerk of Court, Berkeley-Albany Municipal Court, Berkeley, advised as follows:

STEWART ALBERT was one of six persons arrested on the campus of the UCB on November 30, 1966. He was charged with violation of Section 373 and 602L of the Penal Code of the State of California. At a jury trial held in January,

1967, he was found guilty of violation of Section 372 Penal Code (maintaining a public nuisance). The jury was unable to decide guilt or innocence on the charge of violation of Section 602b (trespassing).

For conviction of violation of Section 372 ALBERT was sentenced to 60 days in jail with five days suspended and fined \$330.00 with \$10.00 suspended. An appeal of this conviction was filed and the appeal papers were sent to Superior Court for the County of Alameda on January 24, 1967.

On July 24, 1967, the charge of trespass was dismissed at the request of the District Attorney.

On January 14, 1967, a criminal contempt complaint was filed against ALBERT and others for violating an order issued by the Judge who presided over the trial for trespass and maintaining a public nuisance.

The contempt citation was appealed, and remains on appeal. On November 27, 1967, the court continued this matter until thirty days after a decision is rendered by the District Court of Appeals.

On April 22, 1969, [REDACTED] was recontacted. She advised that the criminal contempt case is still on appeal to the District Court of Appeals. She advised, however, that the Superior Court has upheld ALBERT's conviction of violation of Section 372. This case is docketed for May 9, 1969, at 1:30 p.m., at which time ALBERT is scheduled to appear for execution of the sentence.

U. S. Commissioner's Docket No. 597, Alexandria, Virginia, contains the following information:

STEWART ALBERT, born December 4, 1939, and furnishing a home address of 13 E. 3rd Street, New York City, was arrested by U. S. Marshals at the mall entrance to the Pentagon at 12:20 a.m. on October 23, 1967. He was charged with "refusing to leave." For this offense ALBERT received a \$25.00 fine, a 15-day suspended jail sentence, and six months probation.

[REDACTED] on September 25, 1968, Subject was among a group of individuals carrying a pig at the South-east corner of the Civic Center in Chicago, Illinois, on August 23, 1968. The group was shouting "Pig for President," and "We stand for a garbage platform." They were ordered by police to depart but they continued to shout, not obeying the instructions. Subject was arrested with this group. He was arrested under IR No. 213339, charged with disorderly conduct. U

On December 2, 1968 [REDACTED] ALBERT's case was to be heard in Branch 47, Circuit Court of Cook County, Illinois, on October 21, 1968. On that date ALBERT failed to appear. His bond was forfeited, and a warrant issued. [REDACTED] stated that because this offense is a misdemeanor, ALBERT will not be arrested outside the State of Illinois. U

[REDACTED] furnished the following background information concerning the events leading up to the arrest of ALBERT on October 24, 1968: U

The Academic Senate at UCB in the past created a Board of Educational Development (BED) to encourage and provide for more student participation in course structuring at UCB. A Center for Participant Education (CPE) was created which offered experimental courses beginning in the Fall Quarter, 1968. Sixteen of these courses were offered for regular credit. One of these sixteen courses was entitled "Dehumanization and Regeneration in the American Social Order." This course was described as "Social Analysis 139X." U

During September, 1968, CPE announced that ten of the scheduled twenty lectures of 139X would be delivered by LEROY ELDRIDGE CLEAVER, who is publicly known as the Minister of Information of the Black Panther Party (BPP), and who has served time in a California penitentiary for conviction of the crime of rape. This announcement raised a great controversy throughout the State of California. As a result, the University of California Regents, at a meeting on September 20, established a rule that guest lecturers (such as CLEAVER in this case) would be limited to one U

appearance per quarter in the classroom.

The Regents' decision angered some of the 'activist' students on the UCB campus. In protest of this decision by the Regents, a generally peaceful sit-in was held on the afternoon and evening of October 22, 1968, in Sproul Hall on the UCB campus. This sit-in was spearheaded by student CPE leaders. Between the hours of approximately 10:30 p.m. and midnight, these persons sitting in were arrested and taken from the building. (ALBERT was not present at this sit-in.)

The next day, the controversy continued on the campus. Demonstrators began short, sporadic occupations of campus buildings. At approximately 3:00 p.m. demonstrators began to converge on Moses Hall, a UCB campus building which houses many offices in the Department of Letters and Science. Demonstrators entered Moses Hall and began to barricade themselves in it. They remained all night, until ejected and arrested at 6:00 a.m. October 24, 1968, by police authorities. During these arrests, the police had to dismantle barricades and dodge flying objects thrown from within Moses Hall. Three of the arresting officers received minor injuries. One of the 76 persons ejected and arrested was STEWART ALBERT.

A characterization of the BPP is contained in the appendix attached hereto.

The records of the [redacted] reflect that ALBERT was charged with violation of Section 415 Penal Code (disturbing the peace), 602 J (trespass) and 594 (malicious mischief). He made bail of \$1,650 on the same day.

On April 17, 1969, the records of the Berkeley-Albany Municipal Court (BAMC) regarding this arrest were reviewed by [redacted]. The following was noted: ALBERT was tried in BAMC by jury, and on February 19, 1969, he was found not guilty of violation of Section 594 Penal Code and guilty of violation of Section 415 Penal Code.

The jury was unable to reach an agreement regarding his guilt or innocence on the charge of violation of Section 602J Penal Code.

On March 13, 1969, ALBERT was sentenced to serve thirty days in the County Jail, and to pay a fine of \$250.00 for his conviction on the charge of disturbing the peace. In lieu of the \$250.00 fine, ALBERT will be allowed to serve one additional day in jail for each \$5.00 of the fine which is not paid. On March 18, 1969, a notice of appeal was filed in ALBERT's behalf. An appeal bond was posted, and ALBERT remains free on this bond. No date has been set for a new trial on the charge of violation of Section 602J Penal Code.

Regarding the arrest of ALBERT on February 21, 1969, on April 21, 1969, [REDACTED] furnished the following information:

On January 22, 1969, a "student strike" was called against the UCB by a group of dissident students. The strike was spearheaded by an organization known as the Third World Liberation Front (TWLF). The TWLF publicly made certain demands of the UCB administration, principally regarding the establishment of a college of ethnic studies at UCB. The strikers vowed not to return to classes until their demands were met.

Almost immediately the strike action resulted in violence on the campus. Striking students, assisted by non-students, blocked entrances to the campus and prevented, by force, persons from crossing the picket lines. UCB police, assisted by law enforcement officers from other agencies (requested under a mutual aid pact) were used to quell disturbances and restore order on and near the picket lines.

On many occasions, police were attacked with rocks, cherry bombs, broken glass, and other weapons. Injuries ensued to both strikers and police and considerable property damage was done on the campus.

THIRD WORLD LIBERATION FRONT

The Third World Liberation Front (TWLF) is a coalition of non-white student groups, namely Black, Chicano (Mexican-American), Filipino, Chinese, and Japanese.

A member of the TWLF was quoted as saying, "The first world is the capitalist world, the second world is the Communist white world, and the third world is the non-white world composed of people from Asia, Africa, and Latin America. The first two worlds suppress the non-white people whether in or out of their own countries. We do not distinguish on national lines. We do not relate to countries because by and large they do not represent people."

TWLF self-described itself as "It opposed the oppressive enslavery and colonialist system in the United States and it was dedicated to preparing for a prolonged struggle for freedom in Asia, Africa, and Latin America as well as the United States."

TWLF stated its purpose is to initiate discussion and develop programs pertinent to the needs of third world (non-white) students; to aid further in developing politically, economically, and culturally the revolutionary "Third World" consciousness of racist-oppressed people; we recognize the struggles for freedom of non-white peoples around the world as a positive part of our educational processes.

The "Berkeley Barb" is a tabloid newspaper published each Friday in Berkeley, California, by MAX SCHERR. It describes itself as a member of the Underground Press Syndicate and of the Intergalactic World Brain. A perusal of any issue reveals that it is devoted to reporting on such topics as drug usage, radical student activities, racial strife, and sexual matters.

The paper is opposed to present leadership and authority in virtually every area of American life, including government, business, labor, education, and religion. Publisher SCHERR was recently arrested at Berkeley for publishing an allegedly obscene photograph in the March 21-27, 1969, issue.

ALBERT was interviewed by Special Agents of the FBI on October 28, 1968. At that time, he stated that he was employed as a writer for the "Berkeley Barb" and other papers of the so-called "underground press."

H. Residence

On July 21, 1968, [REDACTED]

[REDACTED] advised that Subject has resided at 2148 East 29th Street for practically all of his life. He is the only child of HAROLD and ROSE ALBERT. HAROLD ALBERT is an employee of the City of New York.

ALBERT is believed to have arrived in the San Francisco Bay Area from New York in approximately October, 1965.

As of June, 1967, ALBERT resided at 1930A Blake Street, Berkeley, California.

ALBERT was arrested at the Pentagon building in Virginia on October 23, 1967. He furnished his home address to the arresting

U. S. Marshals at 13 E. 3rd Street, New York, New York.

[REDACTED] ALBERT was at that time residing at 13 East 13th Street, New York City.

On October 28, 1968, ALBERT was interviewed by Special Agents of the FBI. At that time he stated that he traveled from New York to Chicago during August of 1968, for the purpose of being in Chicago during the time of the Democratic National Convention. After the convention, ALBERT traveled to Berkeley, California, and established residence. As of October 28, ALBERT resided at 1049 Keith Avenue, Berkeley.

ALBERT was again contacted at 1049 Keith Avenue by Special Agents of the FBI on December 9, 1968. On January 20, 1969, another such contact was attempted, at which time an occupant of that address stated that ALBERT no longer resided there.

On January 23, 1969, JUDY CLAVIR (ALBERT's paramour) obtained a telephone in her name at 3286 Kempton Avenue, Oakland, California.

On March 7, 1969, [REDACTED] examined a photograph of Subject. She advised that he is one of the persons apparently residing at 3286 Kempton Avenue.

On March 17, 1969, [REDACTED] advised that the house at 3286 Kempton Avenue, now appears empty, and that the occupants had apparently moved out during the preceding week.

During March of 1969, ALBERT moved to 2917 Ashby Avenue, Berkeley, California. He now resides in the house at that address with JUDY CLAVIR and TOM RAYDEN.

I. Foreign Travel

On June 4, 1964, JC [REDACTED] caused a check of the records of the Passport Office, U. S. Department of State. A record was located which indicated that STEWART ALBERT was issued Passport No. D-015912 on February 1, 1963, at New York. This passport would expire on January 31, 1966, but could be renewed for two more years. On the passport application, ALBERT indicated that he planned to depart from the Port of New York on February 15, 1963, for an eight-month stay abroad for purposes of "study and travel." His proposed itinerary included France, England, Italy, and Spain.

On January 31, 1969, the files of the Passport Office were reviewed by SF [REDACTED]. It was determined that Passport No. D-015912 had expired, and that a new passport had not been obtained by ALBERT.

The December 27, 1968-January 2, 1969, issue of the "Berkeley Barb" carried an article on page eleven under the byline of STEWART ALBERT. This article is reproduced as follows:

On May 13, 1966, the Subject attended a social affair held at 1502 Walnut Street, Berkeley, California, the purpose of which was to acquaint PL members from various areas who were meeting the following day with each other and give them opportunity to talk politics.

On May 14, 1966, the Subject attended a general meeting of PL members held at 225 Valencia Street, San Francisco. The purpose of the meeting was to hear reports from various PLP clubs, which reports would be sent to a National Committee Meeting in New York.

The reports in a discussion centered on the lack of communication with New York and among the California clubs, and the need for more self criticism. The need for further study of Marxism-Leninism was also stressed. There was also a discussion on the need for obtaining sustainers from the community.

Special Agents of the FBI observed the Subject among a group of PLP members departing from the above-described meeting at 225 Valencia Street.

On May 15, 1966, the Subject attended a meeting of PL members held at Mission Club PL Headquarters, 2929 16th Street, San Francisco. At this meeting a Central Committee was elected and the members present were broken up into four groups to discuss student activities, committee activities, labor activities and activities regarding "Spark" newspaper, publication of PLP in San Francisco.

A throwaway leaflet was distributed in Berkeley, California, during May, 1966, advertising a memorial meeting to protest the murder of LEO BERNARD, a member of the Socialist Workers Party (SWP) in New York, which was to be held on the

UCB Campus on May 24, 1966. Listed among the speakers was STEWART ALBERT of the PLP

Characterization of the Socialist Workers Party (SWP), San Francisco Division, and the Bay Area Young Socialist Alliance (BAYSA) are contained in the Appendix attached hereto.

On May 24, 1966 the Subject attended an open meeting sponsored by the Bay area YSA and the SWP at UCB. The purpose of this meeting was a memorial protest in behalf of three individuals who had been shot in Detroit. The Subject, who represented the PLP at this meeting, was one of those who spoke and he spoke of the different atmosphere affecting the "Left" in Berkeley and New York City. He noted that he had recently been arrested for demonstrating in Sacramento and urged all left-wing organizations to work together to help each other in the event of arrests during demonstration, etc.

B. Students For a Democratic Society (SDS)

An article in the November 13, 1966 issue of the "San Francisco Examiner" noted that the Subject was one of three individuals organizing a protest demonstration at the appearance of IGOR ROGOCHEV, First Secretary of the International Relations Division of the Soviet Embassy. ROGOCHEV was scheduled to speak at the University of California, Berkeley, on the effects of cultural exchange programs on the international scene. The Subject was quoted in the newspaper article as saying that Russia's apparent willingness to enter into new cooperative agreements with the U. S. at this time is a betrayal of the North Vietnam government and for this reason a demonstration was being organized against ROGOCHEV.

The "Daily Californian" issue of November 15, 1966 noted that members of the SDS had picketed IGOR ROGOCHEV at UCB and that they in turn were picketed by other members of SDS, who claimed that STEWART ALBERT and his group represented only a minority within the SDS.

The article noted that the group picketing ROGOCHEV called itself the Foreign Affairs Committee of SDS, but an official statement of the SDS Steering Committee noted that the picketing was in no way approved or sponsored by the SDS.

The article noted that ALBERT, a non-student interrupted ROGOCHEV's speech several times to read from a leaflet distributed by the Foreign Affairs Committee.

The "San Francisco Examiner" is a daily newspaper of general circulation published in San Francisco, California.

The Volume 1, Number 1, issue of "Onan," an internal bulletin of the SDS at Berkeley, California, was distributed on the UCB Campus on November 22, 1966. This issue contained an article captioned "New Left Militarism or Old Left Remnants" and criticized the so-called "Foreign Affairs Committee" of SDS composed of STEWART ALBERT and some members of PLP. The article noted that this committee reflected and perpetrated the language and logic of militarism that dominates the United States, the Soviet Union, and China.

The article noted that the questions that the "Foreign Affairs Committee" asked the Soviet representative reflected the kind of militaristic thinking that SDS as radicals are attempting to change.

On December 28, 1966 the Subject attended an anti-draft session of a conference held by the SDS in Berkeley, California. The purpose of this session was to decide upon SDS position on the draft and discussion was held on the proposals of the anti-draft committee of the conference.

C. Vietnam Day Committee (VDC)

On January 3, 1966

STEWART ALBERT temporarily resided at 618 63rd Street, Oakland, California with [redacted] who was active as a tutor in the Negro section of Oakland in a project sponsored by a Methodist church in Oakland.

On December 9, 1965, the VDC held a noon rally at the UC campus, and the Subject worked at the VDC table, selling literature.


In January, 1966, the Subject contacted [REDACTED] concerning the status of the VDC in Berkeley. He said that he has become part of the leadership of VDC and that they are in the process of discussing the future of VDC, and there are some indications that it may go out of existence.

D. National Mobilization Committee
to End the War in Vietnam (NMC).

The NMC was originated at a conference in Cleveland, Ohio, in November, 1966, for the specific purpose of holding massive anti-war demonstrations in New York City and in San Francisco on April 15, 1967. The organization was first titled as the Spring Mobilization Committee to End the War in Vietnam (SMC). Its first Chairman was the noted late pacifist A.J. MUSTE. The founding convention urged all persons interested in the anti-war movement to converge on either San Francisco or New York City on April 15, 1967, to participate in mass marches and rallies protesting United States intervention in Vietnam. East Coast and West Coast headquarters for the SMC were established in New York and San Francisco. The above demonstrations were held. The SMC, however, remained active. Eventually it evolved into the NMC.

[redacted] has previously advised that ALBERT's exclusion from the Peach Torch Marathon Planning Committee was the result of a fight for control of this committee within the SMC. The battleline was generally drawn between Communist Party (CP) elements and their friends on the one hand and elements of the Socialist Workers Party (SWP) on the other hand. The CP people gained control of the Peace Torch planning and then excluded the non-CP members and adherents from the committee.



As of September 21, 1967, STEWART ALBERT is on the NMC staff at its headquarters, 857 Broadway, New York City. ALBERT's duties are that of editor of "The Mobilizer," the official publication of the NMC.



(Previously set forth in this report is the fact that ALBERT was arrested at the Pentagon on October 23, 1967. This arrest arose from the demonstration described above.)

The October 20, 1967, edition of the "New York Times" carried an article entitled, "Leaders of SANE Split on Leftists." The article began as follows:

"The National Committee for a SANE Nuclear Policy is split by a dispute over whether to cooperate with extreme left-wing groups in its campaign against the war in Vietnam."

The article went on to state that certain members of SANE were concerned with the cooperation that some SANE leaders had been giving to the NMC. Particularly disturbing to some SANE members was the fact that Dr. BENJAMIN SPOCK is a Board member of SANE and at the same time is a co-chairman of the NMC. Near the end of the article the following paragraph appeared:

"The officers of the Mobilization (NMC) have never disguised the fact that several prominent communists were on the Administrative Committee. Among those who have publicly identified themselves as such are the following: STEWART EDWARD ALBERT, Progressive Labor Party ..."

"The "New York Times" is a daily newspaper of general circulation published in New York City.

E. Youth International Party (YIP)

In March, 1968, a leaflet appeared in New York City, which announced the formation of the Youth International Party (YIP). The leaflet stated that a group of 25 artists, writers, and musicians have agreed to participate in the founding of this party. The leaflet stated that YIP will stage a massive youth festival in Chicago during the time of the Democratic National Convention. The leaflet urged people to join YIP in Chicago for a festival of youth, music and theatre. The leaflet did not announce any plans for YIP other than the Chicago activity. One of the persons listed as an original founder of YIP was "STU ALBERT."

The October 5, 1968 edition of "The Black Panther" carried a statement from the YIP pertaining to proposed activity for election day, November 5, 1968. This statement is set forth as follows:

Come into the streets on Nov. 5, election day. Vote with your feet. Rise up and abandon the creeping meatball! Demand the bars be open. Make music and dance at every red light. A festival of life in the streets and parks throughout the world. The American election represents death, and we are alive.

Come all you rebels, youth spirits, rock minstrels, bomb throwers, bank robbers, peacock freaks, toe worshippers, poets, street folk, liberated women, professors and body snatchers; it is election day and we are everywhere.

Don't vote in a jackass-elephant-cracker circus. Let's vote for ourselves. Me for President. We are the revolution. We will strike and boycott the election and create our own reality.

Can you dig it: in every metropolis and hamlet of America boycotts, strikes, sit-ins, pickets, lie-ins, pray-ins, feel-ins, piss-ins at the polling places.

Nobody goes to work. Nobody goes to school. Nobody votes. Everyone becomes a life actor of the street doing his thing, making the revolution by freeing himself and f-----g up the system.

Ministers dragged away from polling places. Free chicken and ice cream in the streets. Thousands of kazoos, drums, tambourines, triangles, pots and pans, trumpets, street fairs, firecrackers - a symphony of life on a day of death. LSD in the drinking water.

Let's parade in the thousands to the places where the votes are counted and let murderous racists feel our power.

Force the National Guard to protect every polling place in the country. Brush your teeth in the streets. Organize a sack race. Join the rifle

club of your choice. Freak out the pigs with exhibitions of snake dancing and karate at the nearest pig pen.

Stall for hours in the polling places trying to decide between Nixon and Humphrey and Wallace. Take your clothes off. Put wall posters up all over the city. Hold block parties. Release hundreds of greased pigs in pig uniforms downtown.

Check it out in Europe and throughout the world thousands of students will march on the USA embassies demanding to vote in the election cause Uncle Pig controls the world. No domination without representation.

Let's make 2-300 Chicago's on election day.

On election day let's pay tribute to rioters, anarchists, Commies, runaways, draft dodgers, acid freaks, snipers, beatniks, deserters, Chinese spies. Let's exorcise all politicians, generals, publishers, businessmen, Popes, American Legion, AMA, FBI, narcos, informers.

And then on Inauguration Day Jan. 20 we will bring our revolutionary theater to Washington to inaugurate Pigasus, our pig, the only honest candidate, and turn the White House into a crash pad. They will have to put Nixon's hand on the bible in a glass cage.

in the John F. Kennedy Community Theatre in Berkeley. This
rally was jointly sponsored by the BPP and YIP. STEWART
ALBERT acted as master of ceremonies.

Light shows were displayed, rock and roll bands and
topless dancers performed. YIP buttons were sold, and
contributions were solicited for various causes.

JERRY RUBIN and ELDRIDGE CLEAVER both spoke at
the rally. RUBIN appeared to be under the influence of
drugs and CLEAVER stated that he himself was "stoned"
(under the influence of drugs). The YIP Presidential
candidate, Pigasus the pig, was present in a shopping
cart.

The speeches were generally of a sarcastic nature,

intended by the speakers to be funny. For example, RUBIN stated that he was addressing his remarks primarily to the 7 year olds, as he had lost faith in the revolutionary ardor of those older than 7.

On November 8, 1968, the BPP held a rally in the Civic Center Plaza, San Francisco, California. The rally was held during the approximately time period 12:30-1:25 PM. Approximately 200 persons attended the rally.

KATHLEEN CLEAVER opened the rally, announcing that the purpose of the rally was to show support for her husband, ELDRIDGE CLEAVER. (ELDRIDGE CLEAVER at that time was under order to be returned to prison on November 27, 1968, for parole violation.)

One of the speakers at the rally was STEWART ALBERT, who was introduced by KATHLEEN CLEAVER as the second in command of the YIP.

ALBERT's remarks were overheard by a Special Agent of the FBI. ALBERT expressed support for ELDRIDGE CLEAVER and the BPP.

KATHLEEN CLEAVER is publicly known as the National Captain of Women of the BPP.

F. Activities in Opposition to the Selective Service System

On June 29, 1967, a demonstration was held at the U.S. Army Induction Center, 1515 Clay Street, Oakland, California. Pickets carried such signs as "Hell no, we won't go", "U.S. Get Out of Vietnam", "JOHNSON's War on Poverty-- the Rich Get Richer and the Poor Get Shot." At 7:30 AM, the Oakland Police Department arrested 20 persons for blocking the entrance to the Induction Center.

A Special Agent of the FBI noted that one of the persons present and participating in this demonstration was STEWART ALBERT.

On December 14, 1967, a meeting was held at 2001 Milvia Street, Berkeley, California. The persons present styled themselves as a temporary steering committee for a so-called "Stop the Draft Week", which was to be held during the spring of 1968. The proposed date for the Stop the Draft Week was discussed, but no decisions made. It was decided to introduce the Stop the Draft Week to the students at UCB at a rally on January 10, 1968. A mass meeting for the night of January 10 or 11 was also discussed. STEWART ALBERT was present at this meeting.



On January 10, 1968, a rally to announce a "Stop the Draft Week" was held on the steps of Sproul Hall on the UCB campus. It was announced that Stop the Draft Week would be held during the period February 26 through March 1, 1968. The first speaker at this rally identified himself as STEWART ALBERT. He was observed by Special Agents of the FBI as he spoke about plans for Stop the Draft Week.

A Stop the Draft Week (STDW) mass planning meeting was held at Washington School, Grove Street and Bancroft Way, Berkeley, California, on April 2, 1968. Six persons, including STEWART ALBERT, were elected to an STDW steering committee. It was also announced that ALBERT was one of the leaders of a monitor school, which was preparing for STDW demonstrations. ALBERT stated that he was a monitor captain.



One of the demonstrations during STDW was held on April 23, 1968, at the U.S. Army Induction Center, 1515 Clay Street, Oakland. By 7:00 AM, it was estimated that approximately 1,000 demonstrators were in the immediate vicinity of the Induction Center. During confrontations between the police and demonstrators a small number of arrests were made. STEWART ALBERT was observed by Special

Agents of the FBI as he participated in this demonstration.

In the April 22, 1968, edition of "The Daily Californian", there appeared a story on page one concerning STDW activities. The article identified STEWART ALBERT as a member of the STDW steering committee.

ALBERT indicated that he had been in the May 2 Movement (M2M) in New York.

An article in the "San Francisco Examiner", issue of February 27, 1966, contained interviews of various members of the "new left" as to why they regard the "Great Society" with such contempt. Among those interviewed was STEWART ALBERT, age 23, described as the Co-Coordinator of the Free University of Berkeley. ALBERT said he came to Berkeley from New York City, where he was a case worker in the Welfare Department. He said that after experiencing class hostility to the poor in the Welfare Department, he quit and came to the Bay Area.

A brochure issued by the Free University of Berkeley, listed the courses offered for the first session, starting in February, 1966. STEWART ALBERT, described as a graduate student and activist in VDC, was listed as the instructor in a course on "Revolutionary Thought and Action". This course was described as a seminar to discuss the different avenues to revolutionary change and to study modern revolutionary thought and action. Marxist, personalist, pacifist, and psychedelic perspectives will be considered. Some themes and questions include the relationship of revolution to brutalization, non-violent action and the overthrow of the reactionary political systems; the necessity of a disciplined party and of post-revolutionary dictatorship. Lenin, Mao, Camus, Guevara, Woodcock, Watts, Dostoyevsky.

[REDACTED] the Subject taught a class at the Free University of Berkeley and used as a text the book "State and Revolution" by V. I. LENIN and also the "Russian Revolution" by MOREHEAD. In the class ALBERT attempted to give his own views on the STALIN-TROTSKY conflict.

On January 31, 1966, the Subject was observed by a Special Agent of the FBI in a demonstration of a group of individuals numbering approximately 200, who marched from the campus of UCB to the office of Congressman JEFFERY COHELAN in Oakland, California, to demonstrate against U.S. involvement in the war in Vietnam. The spokesman for the group said the purpose of the demonstration was to urge COHELAN to introduce a bill in Congress to impeach President JOHNSON.

On August 6, 1966, the Subject participated in demonstration in San Francisco protesting U.S. position on the war in Vietnam.

On September 28, 1966, a demonstration by residents of the Bayview and Hunters Point areas of San Francisco took place, triggered by the shooting of a 16 year old Negro youth the previous day by a San Francisco Police officer.

On September 29, 1966, a protest demonstration of some 20 persons took place at City Hall in San Francisco. A leaflet distributed at the demonstration noted that it was sponsored by the Berkeley campus SDS and protested discrimination against the black people and demanded that the police officer involved in the shooting be tried for murder and that the mayor and governor be denounced for using troops to quell a riot provoked by conditions for which they were responsible. Among those observed present by a Special Agent of the FBI was STEWART ALBERT.

An article in the "Daily Californian", issue of January 20, 1967, noted that some 3,000 students marched in protest at the UC against proposed tuition charged at the UC. At this demonstration STEWART ALBERT, who was awaiting trial for an arrest on November 30, 1966, talked to the audience about this issue.

On December 13, 1968, a so-called "conference on revolution" was held on the campus of California State College at Long Beach. This conference was sponsored by the New University Conference, formerly known as the Faculty Peace Committee.

One of the events in this conference was a panel discussion entitled "Cultural/Political Revolution". This

panel discussion was held at 3:00 PM in the Little Theatre on the campus. The moderator for the meeting was Professor CHARLES LEINENWEBER. He introduced the three members of the panel - JIM BERLAND, PETER CAMEJO and STEWART ALBERT.

ALBERT was the first of the three to address the audience. He stated that he was one of the leaders of YIP. He answered many questions from the audience. During the question and answer session, ALBERT made remarks paraphrased as follows:

He believes in the teachings of Chairman MAO Tse-tung and advocated the reading of MAO's writings.

JOHN DILLINGER was one of ALBERT's idols, because "the pigs" were afraid of him, and therefore shot him in the back.

ALBERT called Governor REAGAN of California a "sub-human pig" and also termed President Elect NIXON a pig. He used other obscenities in describing these men.

ALBERT stated that he is not a pacifist, and that violence is necessary to create a situation that will eliminate violence.

ALBERT stated that he has a 30.06 rifle and a shotgun and is learning to shoot. He said people must learn how to shoot in order to protect themselves from the "pigs".

JIM BERLAND publicly identified himself at this meeting as the youth organizer for the Southern California District, Communist Party.

On January 17, 1969, the Board of Regents of the UC held their monthly meeting in Berkeley. Governor REAGAN is a Regent, and was present at this meeting. A Special Agent of the FBI observed, as about 500 demonstrators picketed the building in which the Regents were meeting. Protestors carried various signs, relating to a number of causes, particularly the establishment of a College of Ethnic Studies on the UCB campus. As Governor REAGAN left the meeting, eggs were thrown at his car. STEWART ALBERT was observed present and participating in this demonstration.

H. Activity in Connection with the 1968


FEDERAL BUREAU OF INVESTIGATION

Date October 24, 1968

[redacted] was interviewed concerning his activities during the period immediately preceding and during the Democratic National Convention (DNC), Chicago. The interview was specifically concerned with any knowledge he may have concerning the activities of STEWART EDWARD ALBERT.

[redacted] advised that STEWART ALBERT was commonly called "SIO" and was generally with or close to JERRY RUBIN. He stated that ALBERT appeared to highly regarded and highly trusted by RUBIN.

[redacted] he did not recall when he first met ALBERT inasmuch as he was not familiar [redacted] with any of the individuals who participated in the DNC demonstrations.



On Tuesday, August 27, 1968, after a pray-in in Lincoln Park, ALBERT and others started throwing bottles, bricks, boards, and bags of liquids at a police car which was slowly

moving toward other policemen. He stated the police car was hit numerous times and the crowd began yelling, "Kill the pigs." According to [REDACTED] ALBERT was one of the most vicious, if not the most vicious, of this group.

[REDACTED] as the police attempted to clear the park the crowd would back up about 20 yards, stop, and start throwing various objects at the police while continuing to yell, "Kill the pigs." He stated that ALBERT shouted this phrase as loud as anyone. He stated this continued until almost everyone was out of the park.

[REDACTED] proceeded west on Armitago Avenue until they reached the intersection of Cleveland, where the group including ALBERT started throwing objects at a Chicago city bus. He stated that the group eventually arrived at a house, located one block west of Cleveland on Armitago, where one or more members of the group allegedly was staying and sat on the porch where they watched the police who had subsequently arrived, evidently in response to the attack on the bus, to clear the streets.

[REDACTED] 1968, he was in Grant Park with a group which included STU ALBERT and just after the police moved in to arrest individuals who had attempted to lower the American flag and put up a red flag a melee broke out. He stated that ALBERT and others were yelling, "Kill the pigs," as the police moved in. He advised that a crowd of approximately 4,000 persons began throwing anything they could grasp at the police [REDACTED]

[REDACTED] During this melee a marked Chicago Police car became surrounded by the crowd which was attempting to overturn the vehicle. He stated that ALBERT and others were shouting, "Kill the pigs," while attempting to turn this vehicle over. He stated the vehicle accelerated knocking people aside and sped away. He advised that after the vehicle was free of the crowd, ALBERT stated, "Here we have about 5,000 people and we can't even kill two pigs."

[REDACTED] furnished the following information on September 25, 1968:

[REDACTED] on August 23, 1968, he noticed that a large crowd began to gather at the Civic Center at about 10:00 AM.

Also at this time he noted that a group of individuals who appeared to be "yippie" types were proceeding from the vicinity of an illegally parked Willys station wagon. One of these individuals was carrying a pig.

[REDACTED] he overheard these individuals yelling "Pig for President" and "We stand for a garbage platform". He also heard other individuals in the crowd, who appeared to be only observers, make statements which indicated the "yippie" individuals were not safe in the crowd.

[REDACTED] gave instructions to the "yippie" individuals to depart however they continued their yelling and did not obey his instructions.

[REDACTED] STEWART ALBERT was among the individuals arrested in connection with this incident.

ALBERT was interviewed at his residence in Berkeley on October 28, 1968, by Special Agents of the FBI. This interview was in connection with ALBERT's activities in Chicago during the 1968 Democratic National Convention. A portion of the results of that interview are set forth as follows:

ALBERT advised that he had traveled from New York

to Chicago in August, 1968, for the purpose of participating in a demonstration to protest what he and the "Yippies" considered to be the nomination of a candidate at the Democratic National Convention who would carry on policies of the present administration, specifically that dealing with the Vietnam War.

He stated that he had not entered into any plan to disrupt the Democratic National Convention in Chicago, primarily because he felt that it could not be done with the great number of police and National Guard which he knew would be present to discourage such a thing. He said that inasmuch as the ideological hero of the "Yippies" is GROUCHO MARX of Marx Brothers fame instead of KARL MARX, it was his idea to stage a spectacular demonstration based on the theme of "A Night at the Opera", a Marx Brothers production.

ALBERT said he had no personal part in any riot or violence and could furnish no information in that regard. He said that although he had been struck by someone whom he assumed was a policeman, he did not attempt to strike back and did not throw any objects. According to ALBERT, his arrest by the Chicago police came about when he and several others were carrying a live pig into the demonstration.

ALBERT reiterated that at no time in New York prior to his departure for Chicago, or in Chicago prior to or during the Democratic National Convention, did he plan or advocate riot, violence or disruption of the Democratic National Convention.


